### HAVING REGARD TO

- Regulation (EU) No 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing the Horizon Europe Research and Innovation Framework Programme, laying down the rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013;
- the Council Decision establishing the specific programme implementing Horizon Europe - the framework programme for research and innovation, and repealing Decision (EU) 2013/743/EU, published in the Official Journal of the European Union on 12 May 2021, No. L 167;

**HAVING REGARD TO** Regional Law No. 11 of 19 February 2014, "Impresa Lombardia: per la libertà di impresa, il lavoro e la competitività" (Lombardy Enterprise: for freedom of enterprise, employment and competitiveness) and in particular Article 5-bis which, in order to promote economic development and competitiveness of enterprises operating in Lombardy and employment, provides that the Region shall enhance and support production chains for the implementation of measures aimed at promoting innovation of processes and and organisation, internationalisation, the sharing of resources and knowledge, economic and environmental sustainability, the circular economy and the return of strategic production to the region;

**REFERRING** to Decree No. 18298 of 11 December 2025, concerning: "APPROVAL OF THE EXPRESSION OF INTEREST RELATING TO THE 'AGILE PILOTING - UNITE PROJECT' COMPETITION TO RESPOND TO THE NEEDS EXPRESSED BY THE NORTH MILAN LOCAL HEALTH AUTHORITY (ASST)",  
APPLICABLE TO THE EUROPEAN PROJECT 'UNITE - European Digital Health Valleys' ('UNITE')  
- EX D.G.R. 30/04/2024, no. XII/2285;

### GIVEN THAT:

- the above-mentioned decree set the deadline for submitting applications on the platform accessible at the following address <https://www.openinnovation.regione.lombardia.it/> as 6 p.m. on 16 January 2026;
- 28DIGITAL (formerly EIT Digital), the Executive Agency of the European Innovation Council has extended the deadline for the submission of applications

applications for '*agile piloting*' by 30 January 2026;

**CONSIDERING** that the deadlines for participating in *the agile piloting* coordinated by the individual partners of the UNITE project must be aligned and that 28DIGITAL (formerly EIT Digital) has asked all partners to promote the extension;

**CONSIDERING** therefore:

- to extend the deadline for submitting applications to 6 p.m. on 30 January 2026;
- to confirm all the provisions of Decree No. 11 of 11 December 2025 18298 of 11 December 2025;

**GIVEN THAT:**

- this measure is taken within the deadline set out in the aforementioned decree;
- the expression of interest does not fall within the scope of Articles 26 and 27 of Legislative Decree No. 33 of 14 March 2013, which require the publication on the institutional website of public administrations of data relating to the granting of subsidies, contributions, grants and economic benefits to individuals and public and private entities, but rather follows the rules of transparency of procurement procedures

**HAVING REGARD** TO Regional Law No. 20 of 7 July 2008, 'Consolidated text of regional laws on organisation and personnel';

**REFERRING** to Regional Council Resolution No. XII/628 of 13 July 2023, 'IX Organisational Measure 2023', which appointed Gessyca Golia as Head of the Start-Up, Innovation and Access to Credit for Businesses Unit;

### DECREES

1. To extend, for the reasons stated in the introduction, the deadline for submitting applications for *the* "AGILE PILOTING - PROGETTO UNITE" COMPETITION TO MEET THE NEEDS EXPRESSED BY THE NORTH MILAN LOCAL HEALTH AUTHORITY (ASST)".
2. To confirm all the provisions of Decree No. 18298 of 11 December 2025.
